My wife and I own a Professional Lawn Care company called Lawn Doctor in Cranbrook, which is in the East Kootenays, British Columbia.

It has been in business since 1988.

We service 1,000 to 1,200 clients between Kimberley and Creston and up into the Elk Valley.

When we are fully staffed, we employ two full-time and four seasonal employees, all of whom are certified applicators.

Since 1988 the Lawn Doctor business in Cranbrook has been GROWING INCREMENTALLY — in some years more, some years less.

But since 2010, we have had to REDUCE STAFFING as a DIRECT RESULT OF LOCAL MUNICIPAL BANS ON PEST CONTROL PRODUCTS.

As you have heard previously, the Community Charter is what governs the municipalities in how they can **AFFECT OUR BUSINESS** in terms of pesticide use

We have four of those communities in the area that we service.

I am just going to touch on two of them, which are Kimberley and Fernie.

Those are the two cities that we have — or had — a lot of clients in.

Our clients **DEPEND** on the use of safe and effective products to control unwanted pests such as weeds and bugs.

Federally-regulated products include the herbicides and insecticides that have become the target of much **MIS-INFORMATION** and **FALSE ACCUSATIONS**.

When the municipalities, back in about 2009, started to discuss in earnest — and some, implementing bans on pest control products — OUR GROWTH HAS STAGNATED.

We have had to basically put ANY MAJOR INVESTMENT INTO OUR BUSINESS ON HOLD because of this continued THREAT of a provincial PROHIBITION, also because of the continued threat that the Community Charter allows municipalities to continually impact our business — as well as every other Ma-and-Pa operation across the Province of British Columbia.

As a direct result of the bans — and remember, this is just in Kimberley and Fernie — I'm not talking about our overall business in total — in Kimberley and Fernie, we have LOST OVER 40 PER CENT OF OUR CUSTOMERS in those two banned areas.

The message we continually receive, and again received it this year in 2011, from our customers, when we called them to see if they wanted a repeat return was that —

<< If you can't get rid of my weeds legally, I'll do it myself. >>

What our clients want is they want a reasonably weed-free lawn with curb appeal that they can enjoy.

Needless to say, the ENJOYMENT FACTOR IS DIMINISHING in the communities with the bans, along with the green space infra-structure that those municipalities are looking after.

We expect that, in 2012, WE WILL CONTINUE TO LOSE MORE BUSINESS DUE TO MUNICIPAL BANS.

I fear what will happen if this committee recommends restricting the use of the safe and approved product for home-owners and companies.

PROHIBITION would take away all the gains we have made in the past ten years, and make it DIFFICULT, if not IMPOSSIBLE, TO RECOVER.

I would not be as concerned about this issue if there were ANY Green Alternatives available for us to use commercially.

They are INEFFECTIVE.

They are COSTLY.

You have to use them in two, three, four times the amounts that they say to get ANY results out of them.

In the Community Charter, under the spheres of concurrent jurisdiction of environment and wildlife regulation, municipalities are allowed to PROHIBIT pest control products.

Municipalities have taken the « *Excluded List* » under the Provincial Integrated Pest Management Act, and used it for their own non-toxic or least toxic lists.

Municipal PROHIBITIONS legislation include the « *Excluded List* » for those products that Professional Lawn Care companies can use, saying and thinking that they are Green Alternatives.

Our company has NO REAL GREEN ALTERNATIVES to use on a commercial basis, and, contrary to what somebody might say, there is NOTHING ON THE HORIZON that is being approved by Health Canada.

I'm confident that if you spoke to scientific experts such as Dr. Len Ritter, Dr. Keith Solomon, Dr. Frank Dost, and Dr. Bruce Ames — all of whom are WORLD-RENOWNED SCIENTISTS who have spent their professional careers studying the effects of pesticides on health and the environment — your organization would be much better informed.

In British Columbia, there are over 5000 deaths per year from KNOWN CANCER-CAUSING SUBSTANCES such as cigarette smoke and alcohol. There is NOT ONE KNOWN CANCER DEATH from the proper use of a " cosmetic " pesticide.

The Wisdom of a REAL Expert

In Canada, 97 per cent of the pesticide use is in the agricultural area while less than 1 per cent is used in the domestic (lawn care) area.


In one of the largest studies of its kind, the American Health Study, which followed over 85,000 people associated to the application of pesticides – it found NO EVIDENCE OR LINKAGE to cancers that would stand up to any scrutiny.

Pesticides continue to be some of THE MOST TESTED AND REVIEWED PRODUCTS by agencies around the world. Pesticides have been around for 60-plus years. NOT ONE CASE OF CANCER has been proven to be caused by the occasional use by home-owners.

Such a statement [by Canadian Cancer Society] would make one believe that all the products used in lawn care are linked to cancer, while the use of the same products in agriculture and forestry sector are not.

The government needs to focus on CREDIBLE DOCUMENTED SCIENCE to make responsible decisions on the future of pest control products in British Columbia.

There are NO pesticides that are known or probable carcinogens registered for use in Canada.
