Burnaby resident Linda Cappelletti is still trying to fend off feasting raccoons, skunks, and crows who have TORN APART HER LAWN looking for European Chafer Insects.

Cappelletti thinks the city needs to step in immediately.

Cappelletti is determined to keep the city from forgetting its promise to find a solution to the problem of pesky European Chafer Insects.

[If Burnaby truly wanted to save home-owner lawns from the European Chafer Insects, then it should have its local prohibitions RESCINDED.]

Linda Cappelletti, who lives in a cul-de-sac near Halifax Street, first contacted Burnaby Now in September, after spending HUNDREDS OF DOLLARS on a new lawn only to have raccoons, skunks and crows tear it up in search of European Chafer Grubs.

When Cappelletti called the city to see what they could do to help deal with the troublesome pests, she was told IT WAS OUT OF THEIR CONTROL.

After the story was published, the City of Burnaby told the media it was working on a solution to deal with the city-wide destructive infestation of European Chafer Insects, which would likely include OFFERING RESIDENTS NEMATODE INSECTICIDES AT A REDUCED RATE.

In other words, City of Burnaby has empowered itself as a SUPPLIER OF GREEN ALTERNATIVE PESTICIDES, and has made the decisions to SELL THESE ALTERNATIVES AT THREE TO FIVE TIMES THE PRICE OF CONVENTIONAL INSECTICIDES THAT ACTUALLY WORK.

Since it would be better to DO NOTHING rather than use Nematode Insecticides, and since City of Burnaby has ARBITRARILY AND RECKLESSLY IMPOSED PROHIBITION AGAINST SAFE AND EFFECTIVE INSECTICIDES, City of Burnaby has guaranteed its position as a lucrative supplier in perpetuity.

So when Cappelletti reached out to the city this month in hopes it had implemented its plan to deal with European Chafer Insects, she was disappointed to hear it still wasn't up and running.

She was also told she would have to PAY for the Nematode Insecticides once they became available.

« *It's repetitive,* » she said.

« *I paid 4,000 dollars in taxes and I just spent 700 dollars on the landscaper, and you're not even going to be giving up the product for free ? Do you know how much damage is being done in Burnaby [because of self-imposed prohibition] ? »*

Cappelletti thinks the city should be giving the Nematode Insecticides out FOR FREE, especially considering the amount of damage European Chafer Insects causing throughout Burnaby, including city land.

In neighbouring New Westminster, when the city was experiencing its own European Chafer problem, it OFFERED RESIDENTS COUPONS for 50 per cent off the purchase of Nematode Insecticides.

The City of Burnaby ran a similar program a few years ago, and Councillor Dan Johnston, former chair of the city's Lunatic Environmental Committee told the Burnaby Now in October that council was considering reinstating a similar program this year.

When Burnaby Now contacted Johnston to follow up, he said it would be best to speak with the new chair of the Lunatic Environmental Committee, Councillor Anne Kang.

Kang has yet to return the Burnaby Now's phone call.

With arbitrary prohibitions, such as the ones recklessly imposed in BC municipalities like Burnaby, New Westminster, Metro Vancouver, and Port Moody, green spaces invariably become CHAFER-INFESTED AND DANGEROUS GARBAGE DUMPS.

Residents of in these municipalities like had better get used to living with GARBAGE DUMP GREEN SPACE, since it is IMPOSSIBLE to adequately control damaging insect pests, like European Chafer, without the use of conventional insect control products.

Recommending Entomo-Pathogenic Nematode Insecticides for controlling damaging insects of turf is MIS-GUIDED AND WRONG !

It would be better to do nothing rather than use Nematode Insecticides.

On the other hand, conventional pest control products effectively and safely control insect pests like European Chafer.

In fact, conventional insect control products, such as Merit (imidacloprid), are deemed safer than Entomo-Pathogenic Nematode Insecticides.

In municipalities like Burnaby, New Westminster, Metro Vancouver, and Port Moody, home-owners have NO OTHER OPTION THAN RE-SODDING their lawns, over and over and over again.

If these municipalities truly want to save home-owner lawns from the European Chafer, then they should have their local prohibitions RESCINDED.

Across North America, municipal officials are thinking twice about prohibition by looking at the experience of those jurisdictions that have suffered the hardship and stunningly exorbitant costs of this #@!% nonsense !

In 1940, in the State of New York, the European Chafer was officially identified as a turfgrass pest.

It was accidentally introduced from the Orient and Europe.

Forty years later, in 1980, it reached the Niagara Peninsula in South-Western Ontario.

Its rampage continued across the Greater Toronto Area throughout the 1980s and 1990s.

In 1997, William H Gathercole, one of the foremost turfgrass experts in the nation, first reported its spread to Montreal, Quebec.

By 2001, this insect had also spread across several states of the North-Eastern U.S.

In 2001, Mr Gathercole also first identified the insect in the Pacific Northwest, in New Westminster, British Columbia, while local experts and entomologists were somehow baffled about an insect pest that had created a well-documented ECOLOGICAL DISASTER in urban landscapes throughout Eastern North America.

Additionally, Mr Gathercole exhaustively investigated the introduction of this pest into British Columbia and Quebec.

In both cases, the European Chafer was imported by CONTAMINATED SOD PRODUCTS originating from grower locations in the province of Ontario.

The sod was brought to a location in City of Chilliwack.
