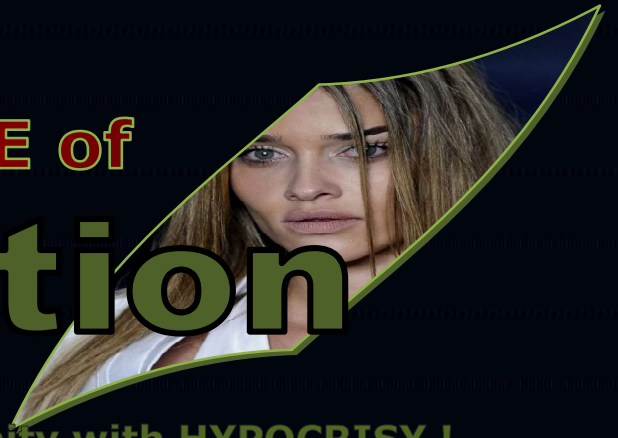

The City of Guelph is located in the Province of Ontario, with a population of 115,000.

Guelph's Anti-Pesticide By-Law came into effect on April 1st, 2008.

Pest control products used in the Urban Landscape were ARBITRARILY DEEMED by Guelph lunatics AS COSMETIC OR NON-ESSENTIAL.

Guelph's CARNAGE Caused by Lunatic-Terrorist-Prohibition

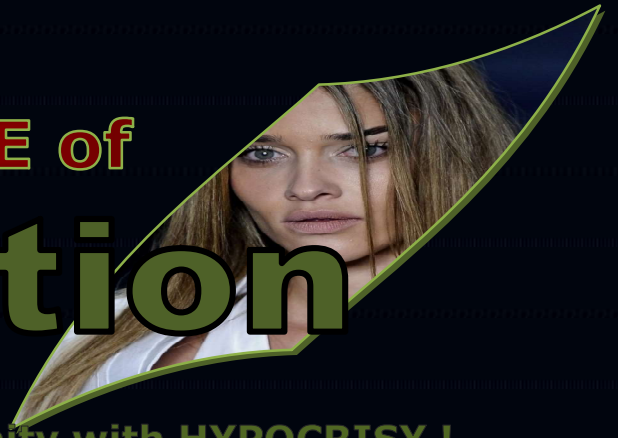
In the City of Guelph, PROHIBITION was DEVASTATING for companies like Kendall Lawn Care, which was founded in 1966.

When it rains, Guelph's playing surfaces are SLIPPERY MUD BOGS.

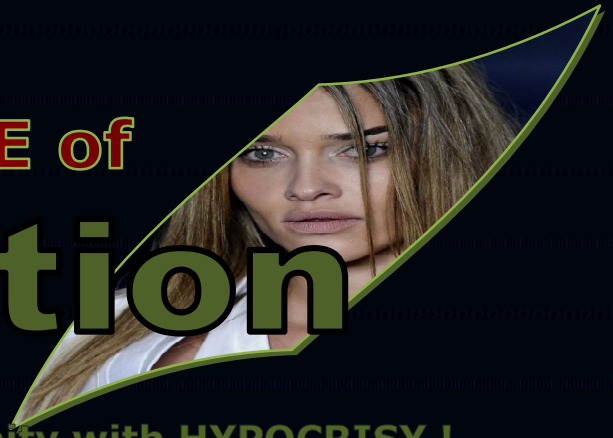
When dry, Guelph's playing surfaces are AS HARD AS CONCRETE.

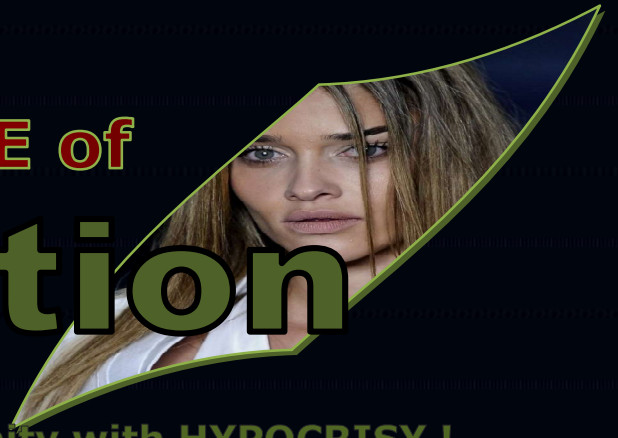
Luckily, with help from the provincial government, our city representatives became heroes and BANISHED THIS VILLAIN FROM OUR TOWN FOREVER.

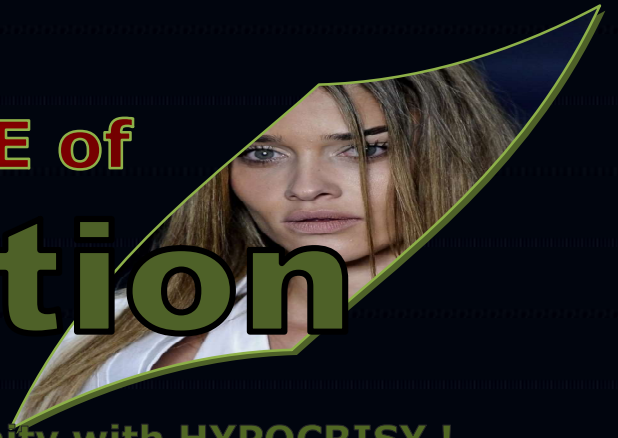

Using the term « *non-native species of weeds* » DOES NOT MAKE THIS HERBICIDE APPLICATION ANY LESS HYPOCRITICAL.

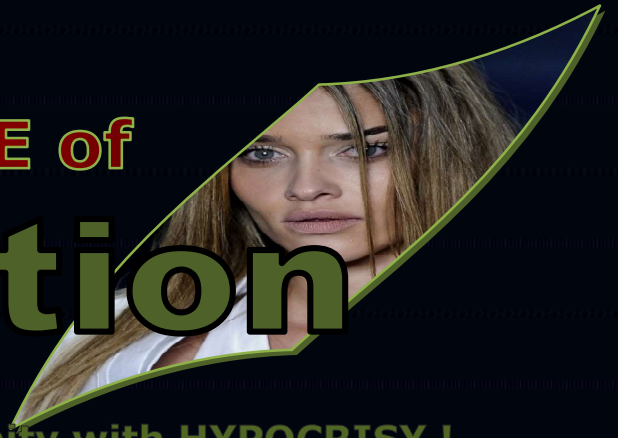
THIS PHRASE IS USED TO MAKE THEIR DECISION TO SPRAY SOUND MORE JUSTIFIED AND NECESSARY.
