« In the short-term, however, the ban may have SIGNIFICANT EFFECTS on the economic health or continued viability of many lawn care businesses, effectively SUN-SETTING components of an industry. »

False Allegations

Since the IMPLEMENTATION of PROHIBITION in Ontario, officials at the University of Guelph have become the INSTRUMENTS of Anti-Pesticide PROPAGANGA for the Government of Ontario by PERPETUATING THE MYTH that there is NO CATASTROPHIC CARNAGE in the 9|11 Era of Anti-Pesticide TERRXR.

Officials at the University of Guelph further ALLEGE that the Professional Lawn Care Industry has been able to remain successful DESPITE the CAR-NAGE of PROHIBITION.

They act as if they are either BLIND & DEAF, or JUST PLAIN STUPID.

Or both.

It is expected that, just as in the Province of Quebec several years earlier, OVER 60 PER CENT of the Ontario Lawn Care companies will be TOTALLY ANNIHILATED.

Because of Anti-Pesticide PROHIBITION, the owners, employees, & families dependent on Professional Lawn Care businesses FACE TERRXR, DESPAIR, & DESTITUTION.

Critical Issues For The Professional Lawn Care Industry

1. The Professional Lawn Care Industry MUST STRONGLY ADOPT THE POSITION THAT CONVENTIONAL PEST CONTROL PRODUCTS ARE SCIENTIFICALLY-SAFE & CAUSE NO HARM.
2. The Professional Lawn Care Industry MUST ALSO ADOPT THE POLICY that its use of ANY FERTILIZERS DOES NOT HARM THE ENVIRONMENT.
3. The Professional Lawn Care Industry MUST OPPOSE ALL FORMS OF PROHIBITION AGAINST PEST CONTROL PRODUCTS USED IN THE URBAN LANDSCAPE. It must OPPOSE even PROHIBITION on PUBLIC PROPERTY since this is a FIRST STEP towards TOTAL PROHIBITION.
4. The Professional Lawn Care Industry MUST ALSO OPPOSE ALL FORMS OF PROHIBITION AGAINST FERTILIZERS.
5. The Professional Lawn Care Industry MUST CEASE ATTEMPTING TO EDUCATE & NEGOTIATE with Anti-Pesticide Enviro-Lunatic Government Officials & Activists. They are to be considered ENEMIES of the industry. Anti-Pesticide-Lunatics WILL NEVER reverse their attitudes AGAINST pest control products. NO ONE MUST NEGOTIATE WITH TERRORISTS, either environmental or political.
6. The Professional Lawn Care Industry MUST ADOPT THE POLICY that the ONLY COURSE OF ACTION AGAINST PROHIBITION IS THROUGH LITIGATION.
7. The Professional Lawn Care Industry MUST LAUNCH LITIGATION against those Anti-Pesticide Anti-Fertilizer Enviro-Lunatic Government Officials & Activists who have CONSPIRED TO PROHIBIT PEST CONTROL PRODUCTS. These products are, in fact HEALTH-CANADA-APPROVED, FEDERALLY-LEGAL, & PRACTICALLY-NON-TOXIC.

Critical Issues For The Professional Lawn Care Industry (continued)

8. The Professional Lawn Care Industry MUST DEM& THAT ALL PROHIBITIONS pertaining to the use of pest control product in the Urban Landscape BE RESCINDED in ALL PROVINCIAL & MUNICIPAL JURISDICTIONS.

9. In those jurisdictions that REFUSE TO RESCIND or IMPOSE PROHIBITION, the Professional Lawn Care Industry MUST DEM& THAT ALL EXCEPTIONS TO PROHIBITION BE RESCINDED. ALL conventional pest control products MUST BE PROHIBITED from industries like agriculture, forestry, golf, mosquito control, nursery, sod production, & sports fields. These industries use the VERY SAME INGREDIENTS that are used to control damaging weed & insect pests by the Professional Lawn Care Industry.

10. In ALL jurisdictions where PROHIBITION has been IMPOSED, LEGAL ACTION MUST BE STARTED. Professional Lawn Care Companies SHOULD SEEK DAMAGES since they will be NO LONGER able to reproduce the business results obtained prior to PROHIBITION, & the VALUE of their businesses will have been DESTROYED.

11. In ALL jurisdictions where PROHIBITION has been IMPOSED, Professional Lawn Care companies MUST DEM& COMPENSATION FROM GOVERNMENT since PROHIBITION will have created LOSS OF REVENUES, BUSINESS FAILURES, BANKRUPTCY, & UNEMPLOYMENT.

12. ALL Professional Lawn Care companies MUST RESIGN THEIR MEMBERSHIPS from ALL Trade Associations that have SUPPORTED the NEEDLESS, SENSELESS, & MALICIOUS PROHIBITION of pest control products. If they are not WITH US, then they are AGAINST US.

Critical Issues For The Professional Lawn Care Industry (continued)

13. The Professional Lawn Care Industry **MUST DENOUNCE** the so-called **GREEN ALTERNATIVES** to conventional pest control products as **BOGUS**. Green Alternatives **DO NOT WORK**. There will likely be **NO** viable, efficacious, or economical Green Alternatives within our collective lifetime.

14. The Professional Lawn Care Industry **MUST DEMAND** that **ALL USES OF NEMATODE INSECTICIDES BE PROHIBITED** until they are registered under federal law. Even though they are Green Alternatives, they are pest control products that **MUST BE REGULATED**.

15. The Professional Lawn Care Industry **MUST ALSO DENOUNCE CULTURAL PRACTICES** as a so-called alternative to the use of pest control products. Cultural practices **DO NOT WORK** in controlling pests.

16. The Professional Lawn Care Industry **MUST SCIENTIFICALLY DEFINE & PUBLICALLY DISCREDIT** the mis-leading term « Organic Maintenance », & establish policies for **EXPELLING** companies using this inaccurate & misleading term from its trade associations. These companies are not **WITH US**, they are **AGAINST US**.

17. The Professional Lawn Care Industry **MUST VIGOROUSLY EMBARK ON A MASSIVE PUBLIC RELATIONS CAMPAIGN** to **STOP** the proposed scheme by Anti-Pesticide Activists & New Democratic Party of Canada (**NDP**) threatening a **NATIONAL PROHIBITION** of pest control products. **NDP** functions as a political shield for the Anti-Pesticide **TERRORIST-Movement**.

18. The Professional Lawn Care Industry **MUST VIGOROUSLY EMBARK ON A MASSIVE PUBLIC RELATIONS CAMPAIGN** declaring that Pesticide-Free Urban Green Spaces are a **DISMAL FAILURE**.

Critical Issues For The Professional Lawn Care Industry (continued)

19. The Professional Lawn Care Industry MUST VERY STRONGLY ADDRESS & DIS-CREDIT ALL MISCONCEPTIONS concerning imidacloprid, 2,4-D, & other ingredients.

20. The Professional Lawn Care Industry MUST TERMINATE ALL RELATIONSHIPS with ALL TEACHING & RESEARCH INSTITUTIONS that SUPPORT the PROHIBITION of pest control products. Including UNIVERSITY OF GUELPH & GUELPH TURFGRASS INSTITUTE. ALL joint activities & educational seminars MUST BE ENDED FOR AN INDEFINITE PERIOD OF TIME. If they are not WITH US, then they are AGAINST US.

21. The Professional Lawn Care Industry MUST OPENLY & FINANCIALLY SUPPORT ALL POLITICAL CANDIDATES WHO OPPOSE ANY PROHIBITION of pest control products.

22. The Professional Lawn Care Industry MUST CEASE focusing on the INEFFEC-TIVE Integrated Pest Management (IPM) strategies as the solution to its public af-fairs problems. Besides, IPM DOES NOT WORK.

23. The Professional Lawn Care Industry MUST ADVOCATE that using its services is SAFER than Do-It-Yourself-Home-Owners.

24. The Professional Lawn Care Industry MUST STRIKE BACK with LITIGATION against its ENEMIES who are Anti-Pesticide Anti-Fertilizer Environmental-TERRKRISTS. These lunatics COULD NOT CARE LESS about SCIENCE-BASED EVI-DENCE. THEY HATE & DESPISE THE PROFESSIONAL LAWN CARE INDUSTRY, & WILL DESTROY IT AT ANY COST.

Green Alternative Pesticides Are Bogus

Despite claims to the contrary, overall, there are NO viable, efficacious, economical, or low-risk alternatives to replace conventional pest control products.

So-called alternatives, such as Corn Gluten Meal, Fiesta, Flame-Throwers, Nematodes, & Sarritor, are DISMAL FAILURES.

Green Alternative Pesticides are INEFFECTIVE, INADEQUATE, HIGH-RISK, INEFFECTIVE, MORE TOXIC, & STUNNINGLY EXPENSIVE.

Green Alternative Pesticides are NOT viable, NOT efficacious, NOT economical, NOT low-risk ...

... most are NOT even legal.

Green Alternative Pesticides are BOGUS & DISMAL FAILURES — they DO NOT WORK.

Green Alternative Pesticides are products that are supposed to REPLACE conventional pest control products.

Green Alternative Pesticides are NOT superior to conventional pest control products.

Unfortunately, there are NO viable, efficacious, economical, or lower-risk alternatives to replace the PROHIBITED products, & there will likely be NONE within our collective lifetime.

There are NO Green Alternative Herbicides that selectively & effectively control weeds in turf.

There are NO Green Alternative Insecticides for Chinch Bugs, a major damaging pest in home lawns.

There are NO Green Alternative Insecticides that effectively control White Grubs, another major turfgrass pest.

Fortunately, CONVENTIONAL pest control products are SAFE, EFFECTIVE, ECONOMICAL, & LOW-RISK.

Virtually all Green Alternative Pesticides are BOGUS, displaying NEGATIVE CHARACTERISTICS such as the following —

- Green Alternative Pesticides are ALMOST TOTALLY INEFFECTIVE except under very specific circumstances.
- Green Alternative Pesticides, such as Acetic Acid & Corn Gluten

Green Alternatives Are Bogus & Dismal Failures



Meal, are PROHIBITED in some municipal jurisdictions.

- Green Alternative Pesticides are questionably HIGHER IN TOXICITY when compared to conventional products.
- Green Alternative Pesticides are STUNNINGLY MORE EXPENSIVE to use when compared to conventional pest control products.
- Green Alternative Pesticides are SUPPLIED by the same Anti-Pesticide Organizations that actively sought the prohibition of conventional pest control products.
- Green Alternative Pesticides may have NEGATIVE SIDE-EFFECTS like phyto-toxicity (an effect that adversely affects plant growth) or metal corrosion or rodent-attractant.
- Green Alternatives, like Nematode Insecticides, are NOT legally registered as pest control products, & therefore, are UNREGULATED.
- Green Alternative Pesticides will NOT fully control pests, & will only provide PARTIAL SUPPRESSION.

- Green Alternative Pesticides will NOT have a full range of safety information such as HUMAN TOXICITY & ENVIRONMENTAL IMPACT, which is necessary for the registration of conventional pest control products.
- Green Alternative Pesticides will require EXTREMELY-HIGH-INPUTS OF ACTIVE INGREDIENT since they will otherwise be less effective — the rates & the frequency of application may be exorbitantly high.
- Green Alternative Pesticides will require MORE PERSONAL PROTECTION for the user.
- Green Alternatives like WEED-BURNING FLAME-THROWERS may BURN DOWN BUILDINGS & HOMES ... just like NAPALM.
- Green Alternative Pesticides are NOT SAFER, NOT BETTER, NOT MORE EFFECTIVE, & NOT LOWER-RISK when compared to conventional pest control products.

Lies Concerning Green Alternative Pesticides
