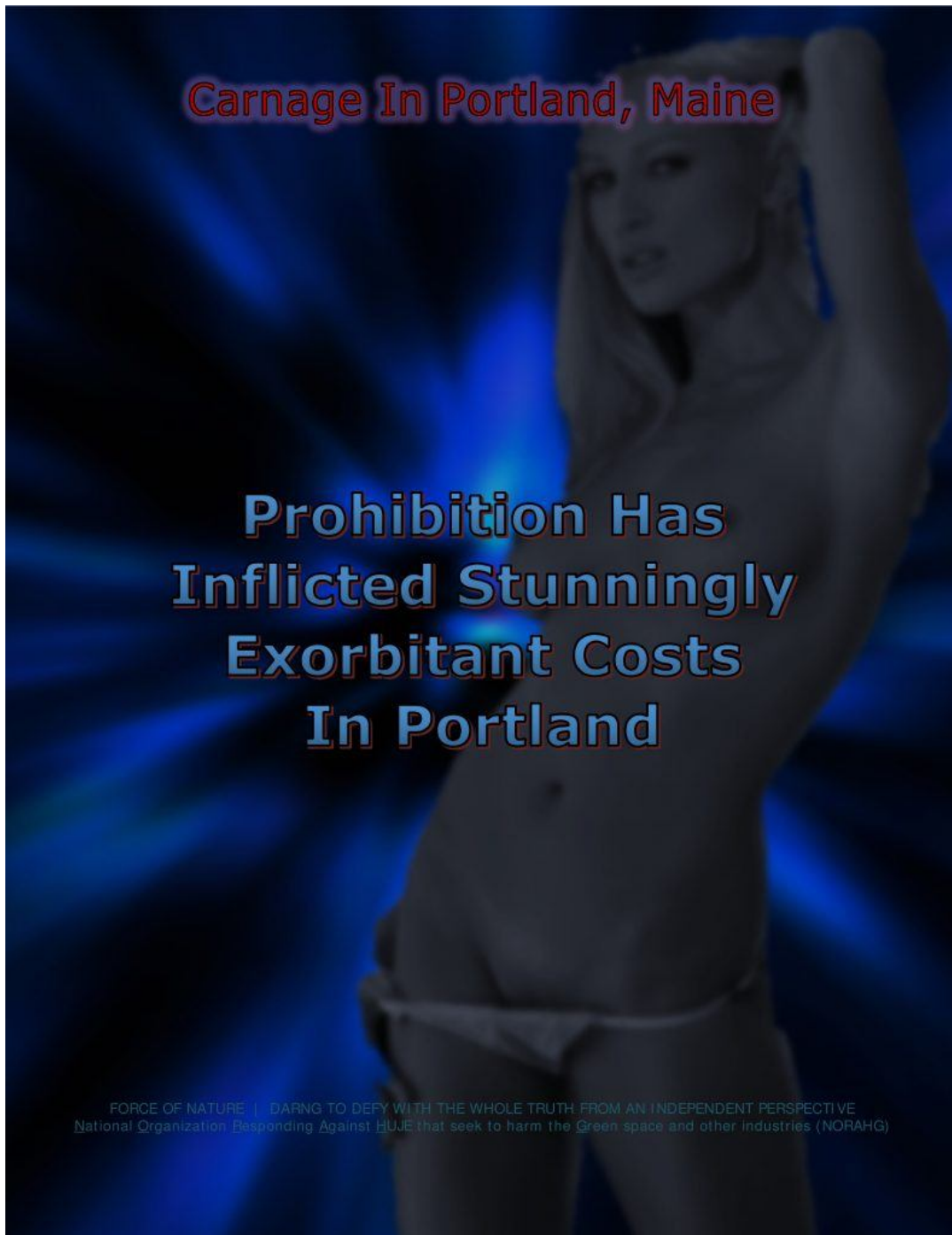

## **The Imposition Of Portland's Prohibition**

Portland is the most populous city in the U.S. state of Maine, with a population of almost 67,000.

The city of Portland, Oregon was named after Portland, Maine.

On January 3rd, 2018, Portland's city council approved a reckless & arbitrary PROHIBITION against the use of conventional pest control products for outdoor pest management on both city-owned and private properties.

The lunatic pesticide-hating councillors voted 9-0 to approve the PROHIBITION after a one-hour workshop that was followed by a lengthy debate on 10 proposed amendments to the proposed law.

Two amendments passed, one of which set the PROHIBITION's start date for July 1st, 2018.

It means that Portland will start using bogus organic pesticides on all city-owned properties beginning summer 2018.

## The Exorbitant Cost Of Portland's Prohibition

### The Cost Of Prohibition Will Be \$700,000

Municipal staff looked into WHAT IT WILL COST TO IMPOSE PROHIBITION on city-owned properties.

A memo presented to city council made an initial implementation estimate of nearly **\$450,000**, and other potential expenses could add almost another **\$250,000**.

In addition to the costs related to implementing Organic Pesticide-Free Management detailed in the regulations, the memo to councillors estimated the cost of possible turf replacement at the five fields between **\$100,000** and **\$250,000**, because conventional ( i.e. synthetic ) pest control products will be PROHIBITED.

The memo detailed implementation costs of **\$25,000** for the education, training and outreach associated with the new regulations; **\$40,000** to fund a sustainability associate part-time position, and **\$60,000** to fund a full-time position for someone to focus on soil care and aeration, seeding and applying liquid organics.

The memo also outlines about **\$300,000** for new equipment, irrigation systems, and tanks and mixing systems for liquid organics.

## The Waivers Of Portland's Prohibition



The use of certain conventional products ( i.e. synthetics ), including herbicides, would be PROHIBITED, unless a waiver is granted by a new Pesticide Management Advisory Committee.

Organic pesticides and allowed conventional products ( i.e. synthetics ) listed on the U.S. Department of Agriculture National List of Allowed and Prohibited Substances would be permitted.

In June 2017, golf course supervisor Gene Pierotti said the reductions were achieved by limiting treatments on the course's 27 holes to once every three years, with treatments made on a rotating basis.

Moreover, it is IMPOSSIBLE for golf courses to keep their facilities playable and attractive by using so-called green alternative pesticides and practices. Alternative methods of pest control are INEFFECTIVE, and CANNOT BE RELIED UPON to properly maintain golf facilities.

There should be NO exception status for golf facilities. The golf facilities in Portland employ the VERY SAME INGREDIENTS that are used to control damaging pests on city-owned and residential properties. In order to be CONSISTENT and FAIR, Portland must provide NO EXCEPTION STATUS for golf facilities UNLESS there is a PROPOSAL that there will be a TRANSITION TO MORE PEST RESISTANT VARIETIES OF GRASS.

The city has already curtailed spraying Roundup on sidewalks to kill weeds, and reduced use of synthetic pesticides at Riverside Municipal Golf Course by up to 60 per cent.

And yet, there are thousands of known deaths per year from known cancer-causing substances such as unhealthy diet, physical inactivity, excess body weight, alcohol consumption, and over-exposure to the sun. Pest control products are SCIENTIFICALLY-SAFE, and WILL NOT cause harm to people, animals, or the environment.

*I support more staffing and equipment.*

*What I do know is organic is a more manual thing, pulling weeds, spreading compost.*

Also included in possible implementation costs is an exorbitant \$24,000 needed to pay for two seasonal employees for MANUAL WEED PICKING at the athletic fields.

## **MANUAL WEED PICKING MEANS BECOMING A COTTON-PICKER !**

Not surprisingly, manual weed picking is totally ineffective. There is no doubt that it will be impossible for home-owners or maintenance professionals to keep their properties weed-free, safe, and beautiful by using practices like weed-pulling, raised mowing height, and soil aeration. Without conventional pest control products, playing surfaces become thin and yellow, and over-run with weeds and infested with insects, resulting in the dismal destruction of safe turf playing surfaces and turning them into garbage dumps. Who wants to live in #@!!% pest-infested garbage dumps just because a small group of fanatѓcs seek to impose needless pesticide bans ?!?! The COST of Portland's PROHIBITION will be \$700,000, in no small part, because of the advice of an incompetent consultant & anti-pesticide lunatѓc, Chip-Charles Osborne.

Osborne is owner of Osborne Organics in Marblehead, Massachusetts, and is a board member of Washington, D.C.-based Beyond Pesticides, an anti-pesticide & environmental-terrѓrist organization.

He has also been providing incompetent advice to South Portland as it implements pesticide regulations approved in September 2016.

As in Portland, the South Portland PROHIBITION is being PHASED-IN, and will apply to private property owners starting in May 2018.

In 2019, PROHIBITION will be extended to the South Portland Municipal Golf Course.

**In South Portland, golf facilities DO NOT GET AN EXCEPTION STATUS.**

Osborne shared a draft of his thoughts on potential costs and organic pest management.

According to lunatжc Osborne —

*Because the field is chemical free does not necessarily indicate that it needs \$100,000 irrigation system.*

Lunatжc Osborne said he did not know what the city would implement to manage its fields, and did not doubt the potential cost of turf replacement, based on what he has seen in other places.

However, he found the premise flawed.

According to lunatжc Osborne —

*It is highly unlikely that athletic fields that do not get pesticides, but ( do ) get a sound, comprehensive, organic program, would need to be replaced frequently.*

*There would have to be a serious lapse in management in order for a field to fall in disrepair that quickly. \**

\* The lunatжc Osborne is WRONG ! The pesticide-free program ALWAYS end in failure, and playing surface must be replaced with natural grass, or converted to artificial/synthetic grass. How can Portland tolerate Osborne's #@!!% organic incompetency !?!?

Anti-pesticide lunatic-activists have infested the city of Ashland, Oregon, but have failed.
