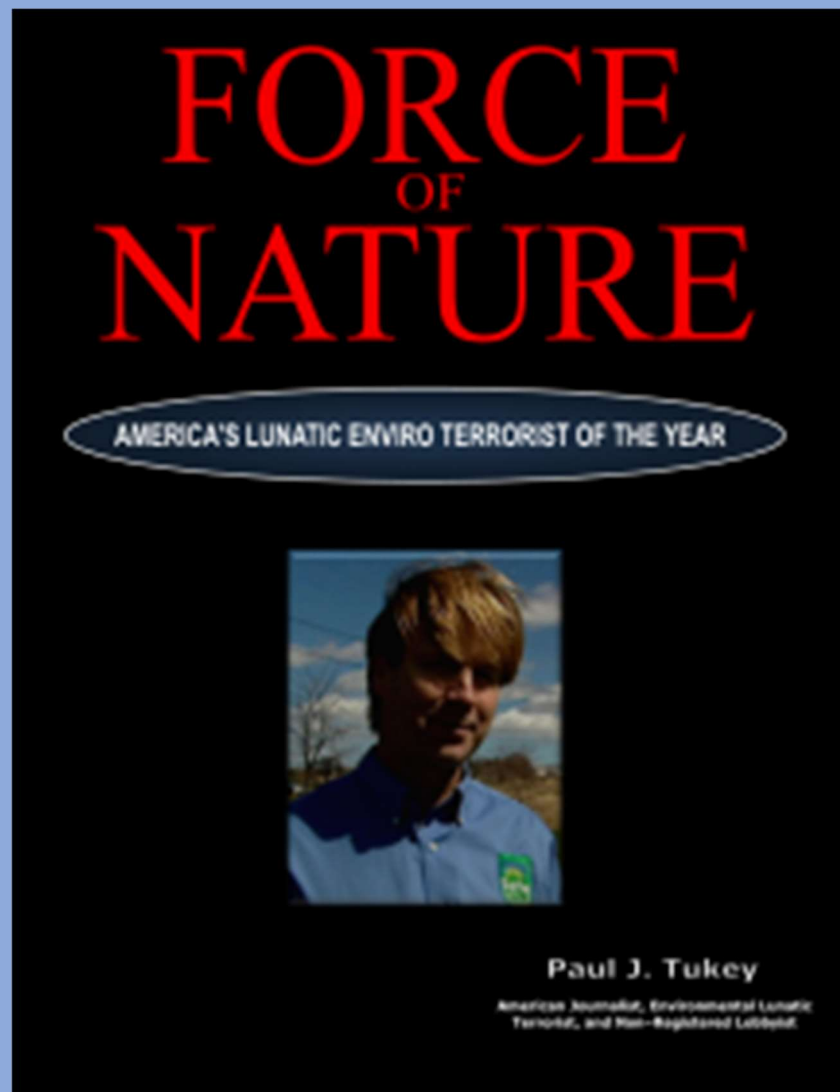

Summary

A company named BCF Lawn & Landscape applied a [NO-RISK-] pest control product on a sports field at Edgewood Middle School, in Ohio.

The product was a federally-legal & EPA-registered herbicide, Momentum FX2, which was composed of 2,4-D, triclopyr, & clopyralid, active ingredients that have been assessed as scientifically-safe, even if children are exposed.

Nonetheless, students allegedly complained to school officials regarding headaches & feeling dizzy.

The story that was concocted by school officials was that the spraying of the [NO-RISK-] pest control product on the sports field somehow caused the students to become ill. [?!?!]

School officials over-reacted, clearly with malicious intent, & contacted hazardous material teams & several emergency crews.

21 students were treated, with 6 being taken to area hospitals.

Laboratory analysis for the active ingredients was performed by a swab sample of a classroom window where students complained of an odor.

THE SWAB ANALYSIS WAS NEGATIVE.

According to a report by Ohio Department of Agriculture ...

*It is **UNLIKELY** that an application of a pesticide by a lawn care company on athletic fields at Edgewood Middle School caused students to become sick.*

Outside of Hudson, Irwin was treated more like a clown, & was almost totally ignored.

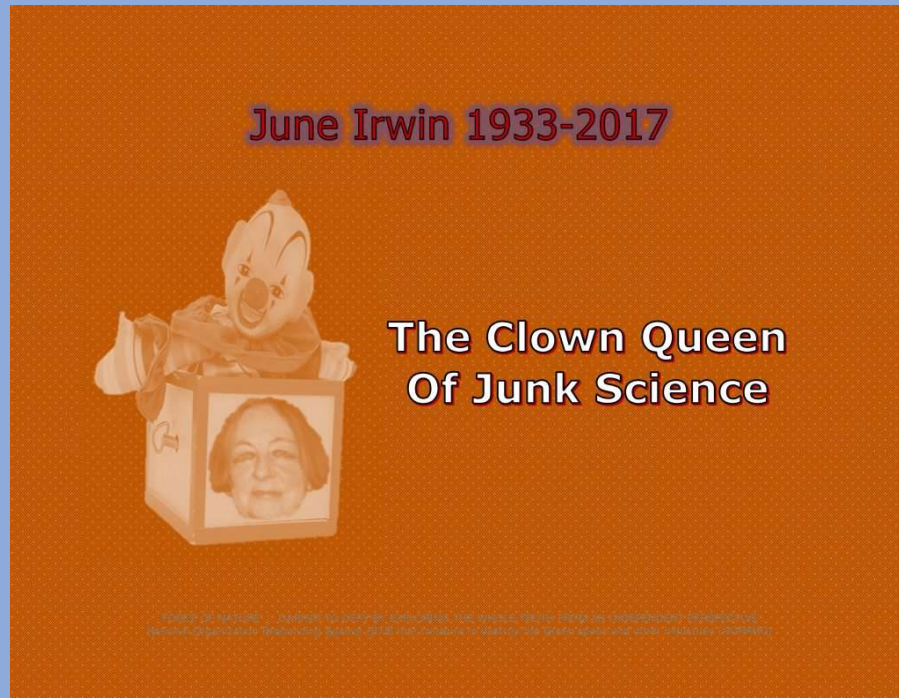

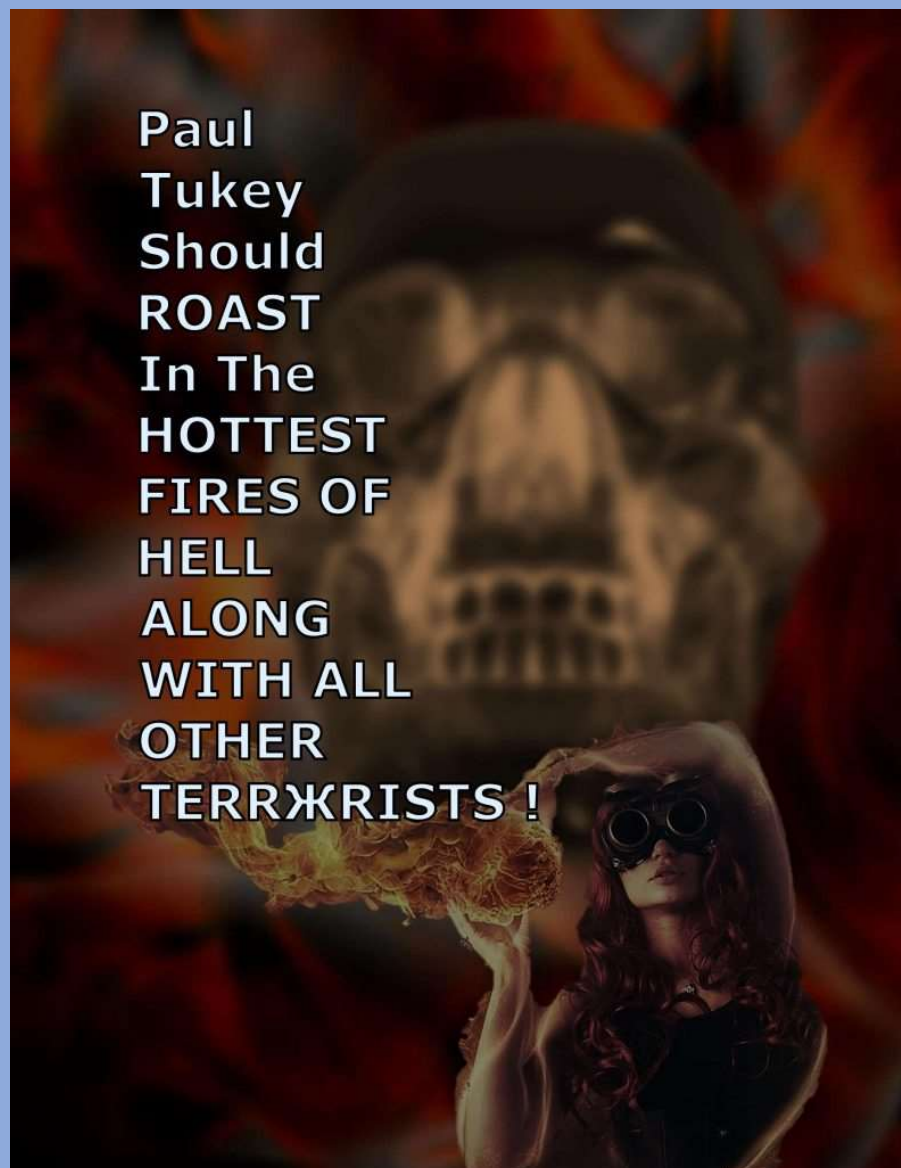
