**The Majority Of EU Nations Do Not
Want Anti-Glyphosate Prohibition**

On November 27th, 2017, the European Union (EU) voted to EXTEND its RE-APPROVAL of the world's best-selling herbicide for an abbreviated period of 5 YEARS, with France and Germany splitting over the move.

With Glyphosate's registration set to expire in December 2017, 18 of the union's member states voted IN FAVOUR OF extending its use for 5 YEARS, 8 nations voted against the proposal and one abstained.

The vote was weighted by population size.

The majority of EU nations DO NOT WANT ANTI-GLYPHOSATE PROHIBITION.

Glyphosate Re-Approved For Only 5 Years Rather Than 10 Or 15

Glyphosate Was Not Approved For The Typical 10 Or 15-Years Because The EU Review Process Was Driven More By Politics Than By Science

The vote capped an unusually lengthy and combative European review process that unfolded amid claims and counter-claims about the supposed cancer-causing risks of Glyphosate.

The deliberations frustrated the Agrochemical Industry.

The Agrochemical Industry criticized the review process was DRIVEN MORE BY POLITICS THAN SCIENCE after it became clear that Glyphosate's use would NOT be RE-APPROVED for the 15 years typical for such chemicals, or even for 10 years.

The Glyphosate Task Force, an Agrochemical Industry group that includes Monsanto and Syngenta, said in a statement that it was ...

... profoundly disappointed at the outcome of today's meeting whereby member states categorically IGNORED SCIENTIFIC ADVICE.

**Chancellor Merkel's Conservative

Glyphosate Approved For Only 5 Years

The EU May Still Be Able To Prohibit Glyphosate's Use After The 5-Year Re-Approval Period

Glyphosate's use in Europe may have a 5-YEAR lease on life, thanks to an EU vote that pitted Germany (in favor of the chemical) against France (which was opposed).

The EU re-approval of Glyphosate came after several rounds of abstentions, and an earlier non-binding vote to prohibit that showed a lack of consensus more than an iron-clad decision.

But 5 years goes quickly, and member nations may still be able to restrict Glyphosate's use.

[Anti-glyphosate terrorism will NEVER end !]

And in 5 years, member country governments (particularly Germany, whose government is currently in its formative stages), could look very different.

In fact, on November 27th, 2017, the vote for the EU re-approval of Glyphosate was close, when Germany voted in favor of its use after months of not voting.

Whether or not Glyphosate will be prohibited permanently remains up in the air, but the EU electoral drama over the past year has generated discussions over the POTENTIAL ECONOMIC IMPACT.

In the United States, pressure from anti-GMO organizations continues to mount because of Glyphosate's use with Roundup Ready crops that are genetically-modified to resist Glyphosate.

In Europe, where GMO crops have NEVER been approved, the controversy has revolved around so-called HEALTH ISSUES from using Glyphosate.

Impact Of Proposed Prohibition

In response to the proposed prohibition against Glyphosate, the president of the French Grain Producers' Organization wrote to Vytenis Andriukaitis, European Commissioner responsible for Glyphosate issues (and the Commissioner for Health), in October 2017 —

I will suffer SIGNIFICANT DAMAGE, including a SIGNIFICANT INCREASE IN MY PRODUCTION COSTS (use of larger amounts with other herbicides and increase in the frequency of herbicide treatments), dirtying of my plots with many weed species, including perennials.

My working methods should evolve with a return to plowing, the removal of new simplified farming techniques, based on plant cover.

I could NOT practice agro-ecology anymore.

Impact Of Proposed Prohibition

Manufacturing

Glyphosate has been registered by Monsanto for use in more than 130 countries as of 2010.

Analysts have estimated that Monsanto could lose out on up to \$100 million of sales if Glyphosate is prohibited in Europe, according to Reuters.

Of course, since the patent for Glyphosate is now in the public domain, many other firms also manufacture a version of the herbicide, and could also stand to lose.

Considering the LACK OF A TRUE ALTERNATIVE — with the same effectiveness on weeds, toxicity profile, and cost of use — THE ECONOMIC IMPACTS LOOK SIGNIFICANT.

Impact Of Proposed Prohibition

France

According to a story in Bloomberg, the French research institute Arvalis suggested an anti-glyphosate prohibition would have an ECONOMIC IMPACT on the country's agriculture industry of 976 MILLION EUROS (1.1 BILLION DOLLARS US).

Impact Of Proposed Prohibition

Germany

And in Germany, the Kleffmann Group said restrictions could HURT barley and corn output — with PROFIT MARGIN SHRINKAGE between 40 and 70 per cent — as farmers start planting alternative, more profitable crops.

The German Kleffmann Group, and others, noted that the loss of Glyphosate would FORCE MORE FARMERS INTO CONVENTIONAL PLOWING (tillage), which INCREASES output of carbon dioxide, consumption of diesel fuel, and use of heavy machinery, with all the accompanying environmental problems that herbicides like Glyphosate were designed to eliminate.

That comes to 180,000 more tons of diesel and 18 million more hours of labor in Germany alone.

Impact Of Proposed Prohibition

United Kingdom

Meanwhile, in the United Kingdom, where, in 2014, 2.2 million hectares of farms — a third of arable land — was treated with Glyphosate, Oxford Economics estimated the impact would REDUCE wheat yields by 12 per cent, oilseed/rape yields by 14 per cent, and cereal production by 15 per cent.

Agricultural contributions to the nation's GDP would shrink by about 930 million British pounds (1.23 billion dollars US).

Impact Of Proposed Prohibition

World-Wide

A prohibition also will affect world trade of not only Glyphosate, but also of foods grown.

If a true anti-glyphosate comes to fruition, then it would be up to the EU and/or member countries to decide to prohibit imports of food grown with Glyphosate.

And a lot of food grown with Glyphosate is imported into Europe.

Annually, the EU imports tens of millions of tons of genetically-modified (Roundup Ready) soybeans and other crops, used for animal feed.



Impact Of Proposed Prohibition

Tolerance Levels

The import of food grown with Glyphosate could be halted if the EU decides that, based on [supposed] HEALTH ISSUES, that the TOLERANCE LEVEL of Glyphosate in imports (or any other foods and crops) is reduced from 20.00 milligrams per kilogram to 0.01 milligrams per kilogram.

If the decision by the EU is made for NON-HEALTH ISSUES, then the TOLERANCE LEVEL can be higher than 0.01 milligrams per kilogram.

But with Vytenis Andriukaitis, the EU Health Commissioner in charge of Glyphosate issues, and the arguments so far being based on HEALTH ISSUES (and the IARC monograph's [false] connection to cancer), THE DECISION TO PROHIBIT AGAINST GLYPHOSATE WILL LIKELY BE A HEALTH-BASED ONE.

The farmers DO NOT have much of a voice here since the dossier will be handled by the Directorate General for Health and Food Safety.

Which means, David Zaruk, a Belgium-based risk specialist, says, that farmers WILL NOT have as much influence on the decision as they might if it were being debated by the EU Agriculture Commissioner.

Impact Of Proposed Prohibition

Anti-Pesticide & Environmental-Terrxrist Organizations

Anti-pesticide groups like Pesticide Action Network, Friends of the Earth, European Green Party, and others, are [**falsely**] tying Glyphosate to HEALTH ISSUES, and NOT as a GMO issue, since there are NO Glyphosate-resistant seeds in the EU.

Some organic groups point to the possibility of Glyphosate-free farming, but admit it WILL NOT BE CHEAP OR EASY.

Fanatxcal-lunatxk Urs Niggli, from the Research Institute of Organic Agriculture (FiBL) in Frick, Switzerland, maintains that farming can go on without Glyphosate, but ...

*... for a truly environmentally friendly agriculture without Glyphosate, the WHOLE SYSTEM WOULD HAVE TO BE CHANGED in the USA, Brazil and partly also in the EU — establish multi-factorial crop rotations, sow ground cover crops like clover and grass regularly to suppress the weeds, as well as undercutting for maize and grain. [**?!?**]*

Health Canada, the European Food Safety Authority and a joint WHO and United Nations Food and Agriculture Panel published similar scientific reviews in 2015 and 2016.

All of these organizations reported that glyphosate is NOT carcinogenic for humans.

According to Dr Strang —

To determine the actual risk you have to ask exactly how is the chemical going to be used — when, how, where, and how much — and work all that through in a risk assessment to say what's the possible human exposure and what are the health risks from that exposure.

All the evidence would say that the way it is proposed to be used in Nova Scotia for forestry application DOES NOT pose any human health risk.

Dr Strang went on to cite a recent New Brunswick study with similar findings, and said it's about weighing risks and benefits.

In 2011, glyphosate was one of a number of ingredients whose use was arbitrarily prohibited in the urban landscape by the government of Nova Scotia.

2,4-D and glyphosate are LESS TOXIC than Aspirin, baking soda, caffeine, cannabis, nicotine, table salt, and Tylenol.

2,4-D and glyphosate are NO MORE TOXIC than ethanol (an edible beverage constituent in beer, wine, and other intoxicating beverages), mouthwash (Listerine), and Vitamin C.

Pest control products like 2,4-D and glyphosate are scientifically-safe, practically non-toxic, will cause NO harm, WILL NOT cause cancer, and WILL NOT cause irreversible damage if consumed orally.

The probable lethal dose for a person ingesting the concentrated form of 2,4-D or glyphosate is one litre, the volume of an entire milk carton.

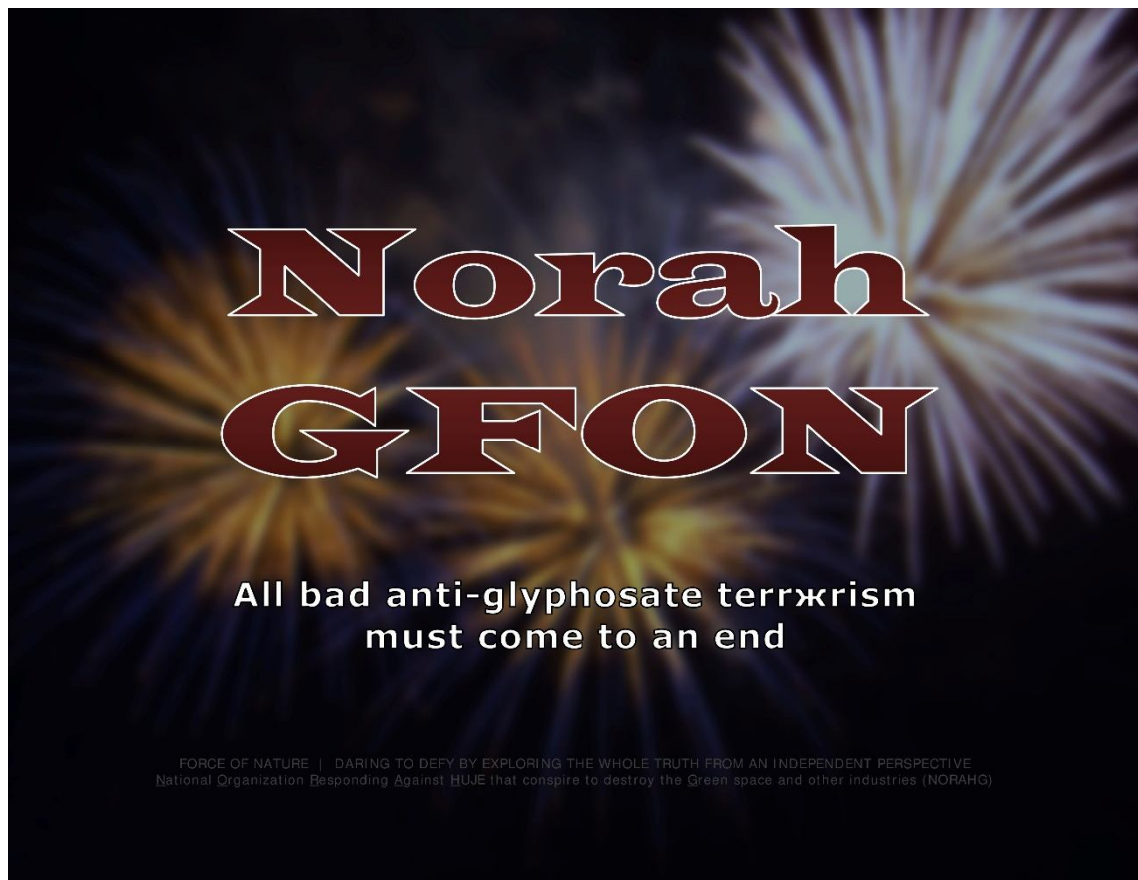
