Lindeblad V Manufacturer

Bayer Giving-In To Extortion

Bayer, the German pesticide and seed company, has agreed to establish a **10,000,000,000-DOLLAR FUND** that aims to resolve current litigation and address potential future litigation over its [**NO-RISK**] Roundup-branded glyphosate weed control product.

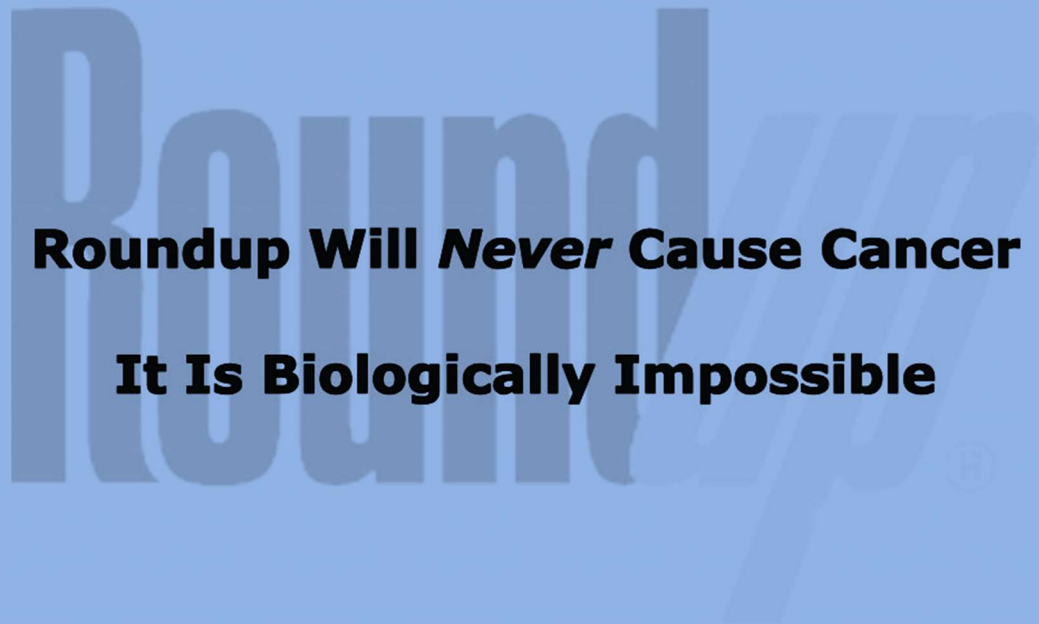
