# **Glyphosate Research**

On June 14th, 2019, Bayer sought to REPAIR ITS REPUTATION after damage caused by US litigation over [false] claims its glyphosate causes cancer, saying it would invest 5,000,000,000 Euros (5,600,000,000 Dollars US) in herbicide research.

Bayer's shares hit seven-year lows after a California couple received UNJUSTIFIED JACKPOT AWARDS of more than 2,000,000,000 Dollars US in the largest-ever US jury award over claims that glyphosate-based herbicide Roundup [somehow] causes cancer. [?!?!]

As well as saying it would invest 5,000,000,000 Euros in research over the next ten years, Bayer promised to reduce its environmental impact by 30 per cent through 2030 via measures such as more precise and more sparing application of crop chemicals.

According to Bayer —

While glyphosate will continue to play an important role in agriculture and in Bayer's portfolio, the company is committed to offering more choices for growers.

Bayer maintains that glyphosate is safe.

Its move follows a third consecutive US jury verdict against Roundup.

A spokesman said the investments in weed control were part of a previously approved budget.

Bayer has beefed up its public relations machine in an attempt to repair its image, which also faces a back-lash in Germany over a COLLAPSE OF INSECT POPULATIONS [?!?!], which environmentalists blame on pesticides used in farming.

Bayer said it would seek to reduce its environmental foot-print by scaling down crop protection volumes and enabling more precise application.

It would increase transparency around research efforts and the forthcoming process of re-registering glyphosate in the European Union.

According to Bayer —

This will help to restore and retain bio-diversity, combat climate change, and make the most efficient use of natural resources.

Bayer added it will only sell crop protection products in developing countries if they also meet the safety standards of a majority of eight leading global regulators in jurisdictions such as the EU, the United States or Brazil.

Western crop chemicals companies have faced criticism from [glyphosate-hating environmental-fanatxcs] for selling products in developing countries with local approval, even though clearance at home had ended.

A spokesman said NO products had been withdrawn yet and Bayer would now look into its product portfolio.

# Glyphosate Will Not Cause Cancer

#### No Association Between Glyphosate & Cancer

#### Summary -

The US National Cancer Institute ( US NCI ), a science-based research organization, concluded that — glyphosate was NOT statistically significantly associated with cancer.

This large long-term research was published in the Journal of the National Cancer Institute (JNCI).

This was the largest research study of agricultural workers in history, a gold standard, over the longest period of time.

It definitively demonstrated in a real-world environment that glyphosate DOES NOT cause cancer.

## Statement By National Institutes Of Health (NIH) Conclusions —

In this large, prospective cohort study, no association was apparent between glyphosate and any solid tumors or lymphoid malignancies overall, including NHL and its subtypes.
